## Lane County Historical Society Heritage Outreach Grants

### **Grant Guidelines**

The Lane County Historical Society is requesting proposals for grants addressing the investigation, preservation, recording, or interpretation of Lane County History.

Our aim is to stimulate an understanding and appreciation of our county historical heritage by helping to accomplish specific programs and projects through financial assistance. In general, individual grants will range in amount from \$250 to \$2,500.

- Preference will be given to endeavors related to:
  - o museum collections
  - o public programs
  - o public events
  - o historic preservation
  - o original Lane County historical research.
- Applicants are preferred to be, but are not limited to:
  - o non-profit organizations organized under one of the various 501(c) statutes,
  - o private groups and institutions
  - o commercial and historical/cultural entities
  - o non-governmental and tribal organizations
- In order that all areas of the county might better benefit from the program, consideration will also be given to geographic spread of the grants.

Clear and concisely written proposals have the best chance of being funded. The scope of the proposals should be appropriate for a one-year funding period. Additional project support beyond the first year of funding requires a second proposal and explanation for additional funding, to be reviewed in competition with all proposals submitted during that funding cycle:

- Application deadline- Nov 1, 2019
- Public announcement of recipients, presentation of checks- Feb 16, 2020
- Funds available for projects starting before June 30, 2020
- Formal reports for these projects are due no later than June 30, 2021

NOTE 1: Institutional indirect costs such as travel, debt relief and the cost of seminars and conferences are not eligible for program support.

NOTE 2: Heritage Outreach Grant funds may not be used retroactively to pay for expenses incurred before project recipients are formally notified of selection.

# Lane County Historical Society Heritage Outreach Grants

#### Grant Submission

Grant applications may be submitted in person, by mail or electronically. Applications will be reviewed and submitted to appropriate reviewers, specifically the Outreach Committee of the Lane County Historical Society. The Outreach Committee will then forward its recommendations to the Board of Directors for final approval. Transfer of approved funds for specific grants are handled by the LCHS Executive Director.

Note: Persons making a proposal or related to an organization making a proposal may not serve as a reviewer.

### Final Report

A written final report on the grant project outcome will be required not less than one month after the project completion date stated in the grant application or at the end of the grant cycle.

Extensions of time require a special written request.

Failure to file the formal report is automatic disqualification for future grant awards and may require the return of grant funds.
